Privacy Statement

GDPR Website Privacy Exertis Benelux B.V.

Exertis Benelux B.V. (hereinafter: Exertis Benelux) respects the privacy of all users of its websites and ensures that your personal data is handled carefully and confidentially. The purpose of this Privacy and Cookie Policy is to inform you about how Exertis Benelux complies with the General Data Protection Regulation (GDPR) and how Exertis Benelux uses your personal data. Personal Data

The personal data you provide to Exertis Benelux, for example when requesting information, logging in or registering, or ordering one of our products, will be recorded in the database of Exertis Benelux. This includes the following personal data:

The following personal data is automatically collected when logging in:

Purpose

Your personal data may be used by Exertis Benelux for the following purposes:

- 5. Product and service development;
- 6. Website improvement;
- 7. Market research and statistical analysis;
- 8. Transport information;
- 9. Compliance with legal and regulatory obligations;
- 10. Fulfilling agreements with you (e.g., delivering the shipment).

Processing by and disclosure to third parties

Exertis Benelux may disclose your data to third parties involved in the execution of your order or the services of Exertis Benelux, including the carriers Exertis Benelux works with. Additionally, your data may be processed by third parties for market research or statistical analysis related to the services and website usage. Exertis Benelux will make agreements with these third parties to ensure the confidentiality of your personal data is respected. This is stipulated in a data processing agreement. We will not disclose your personal data to law enforcement, other government officials, or third parties without a court order or formal government request in accordance with applicable laws, unless Exertis Benelux believes in good faith that such disclosure is justified.

Security

We will take all reasonable organizational and technical security measures to protect your personal data and safeguard it against loss, misuse, or alteration. The data you provide when registering and ordering is transmitted over the network via a secure protocol. Exertis Benelux performs a daily virus check to ensure that our website remains as virus-free as possible.

Retention of your personal data

We do not retain your data longer than necessary for the purposes for which it was collected and processed. We also delete your data if it is found to be outdated or if the individual concerned requests deletion, see 'Access and correction.' Data linked to an account is stored until the account is deleted. The above retention periods do not apply if a legal exception exists, or if we need the data longer for our services or a dispute.

Access and correction

You have the right to request access to your personal data from Exertis Benelux. Exertis Benelux will provide an overview of all personal data processed within four weeks upon request. If your data is incorrect, Exertis Benelux will correct it upon request. You can also request the deletion or restriction of your personal data.
